FROM SOCIAL ACTION



An important part of our Social Action is to advocate for justice. I am providing information and links to two current email campaigns of United Women in Faith. Included in the description below of each campaign is a link to a prepared email that you can use to automatically contact your representatives. All the difficult work is done for you. All you need to do is add your contact information. You may revise the message to personalize it if you wish. You can share your own stories and statements to explain why this issue matters to you. If you'd like, you can then click through to an additional next step, speaking directly to your legislators' staff members by phone to reiterate this important message in your own voice. This added step can make a big difference in the impact of your advocacy.

1. Lift Your Voice to End Corporal Punishment in Schools

As women of faith, we believe all children and youth are sacred, beloved by God, and deserving of an education that nurtures their God-given gifts and encourages their ongoing growth. The use of corporal punishment in schools undermines student safety and well-being. It is disproportionately used against Black and Native American students, and the echoes of historical violence are disturbingly clear. Corporal punishment should be banned in our schools. United Women in Faith joins Nollie Jenkins Family Center, the Mississippi Coalition to End Corporal Punishment, the Dignity in Schools Campaign, and other long-time leading organizations across the country to urge passage of the Protecting Our Students in Schools Act.

Every member and friend of United Women in Faith is encouraged to take a simple first-step action today: Use the email tool on the link below to urge your legislators to cosponsor this important bill. You can share your own stories and statements to explain why this issue matters to you and/or use the template language already provided. If you'd like, you can then click through to an additional next step at the top of the form to speak directly to your legislators' staff members by phone to reiterate this important message in your own voice. 2. Climate Justice

"You care for the land and water it; you enrich it abundantly. The streams of God are filled with water to provide the people with grain, for so you have ordained it. You drench its furrows and level its ridges; you soften it with showers and bless its crops. You crown the year with your bounty, and your carts overflow with abundance. The grasslands of the desert overflow; the hills are clothed with gladness. The meadows are covered with flocks and the valleys are mantled with grain; they shout for joy and sing" (Psalm 65:9-13)

We have a moral responsibility as a nation, and a sacred task as people of faith, to care for our climate and to leave a safe and thriving world for future generations. That's why we need more legislation to prioritize climate justice that will deliver protections and justice for impacted communities, jobs, climate action, and clean energy.

We need more historical investments in climate action that protect both people and creation and ensure that funds prioritize environmental justice and frontline communities and exclude problematic subsidies for fossil fuels and other polluting energy sources. we advocate for clean and just energy and environmental policies such as:

- H.R.1705 & S. 919 Environmental Justice for All Act
- H.R. 3302 & S. 1601 Protecting Moms Against Climate Change
- H.R. 963 & S. 68 A sustainable climate addressing an equitable Farm Bill
