She further pursued her education by attending Tennessee State University in Nashville, Tennessee and received a B.S degree in Bio-Chemistry and a minor in Sociology.

Upon graduating she was employed by the Tennessee Department of Agriculture and has been there for 30 years. She currently holds the position of Pesticide Administrator and has the responsibility of overseeing the use, miss-use, application, sale and distribution of pesticides across the state. She has been the past president of the Association of Southern Feed, Fertilizer and Pest Control Officials (ASFFPCO), Tennessee Vegetation Management Association (TVMA) and EPA Region IV Pre-SFIREG Chair (State FIFRA Issues Research and Evaluation Group).

Kathy has been active in United Methodist Women since she was 5 years old. She has held offices on the local, district and conference level. At present, she is president of the Southeastern Jurisdiction Leadership Training Team.

She is a member of Gordon Memorial United Methodist Church and within her local church she is the Finance Chair and Leadership Council Secretary. She has held several other positions.

On the conference level she is the treasurer for TN BMCR and lay member of Congregational Development.

Above all else she is a child of God and cannot do anything without his guidance. One of her favorite verses is "I can do all things through Christ that strengthens me".

She loves listening to all types of music, but especially Christian and Classical music as well as collecting various types of cookbooks, the key word is collecting and not cooking.

Women's Division Proposes Becoming "Structurally Separate, Missionally Connected" to Global Ministries

The Women's Division board voted to become structurally separate from the General Board of Global Ministries (GBGM) while remaining "missionally connected" in staff configuration and by its board of directors at its recent meeting, April 7-11 in Stamford, Conn. The directors of GBGM also approved the proposal at their meeting, April 11-13.

Based on recommendations from the board's policy committee, there was strong support of the proposal to be structurally separate and missionally related to GBGM. These recommendations came out of the previous Fall 2010 meeting request to prepare two plans for consideration at the Spring 2011 meeting, one outlining structural connection with GBGM and another outlining structural separation.

Changes in Relationship

The plan would bring a variety of changes to how the Women's Division and GBGM relate to each other.

- The Women's Division would name 5 directors to the proposed 30-member GBGM board. The Women's Division "would intentionally release seats at the GBGM Board of Directors ... to make it possible for GBGM to add additional representation from Central Conferences within a smaller board," a preliminary proposal noted. "We see releasing five seats on the GBGM board as an investment in Central Conference board membership," said Harriett Olson, deputy general secretary of the Women's Division, "and especially in the women of the Central Conferences, who we hope GBGM will agree to seek as directors."
- Women's Division would not be represented on GBGM's Program Cabinet on a regular basis, but is recommending that its chief executive would be represented at the General Secretaries' Table, a body composed of top executives from the 13 agencies of the United Methodist Church.
- Staff structures would be separated, although Women's Division and GBGM have already agreed that Women's Division may continue to purchase some shared services from GBGM as it does now.

"Streamlining UMW, Inc.

As well as recommending becoming "structurally separate" from GBGM, the board took several actions to strengthen missional connections within the organization.

The board approved changes that will be reflected in the constitutions of local, district, conference and jurisdictional organizations of United Methodist Women in order to offer members more flexibility to shape the organization as they see fit. The board approved amending organizational documents to refer to the local organization of United Methodist Women instead of the "unit."

Constitutional language will also flip the norm from larger to smaller officer teams, only naming President, Secretary and Treasurer as required positions to be filled. Functions can be handled as determined by the group to encourage officer teams to develop more organic, mission-focused organizations.

The board voted to all the whole organization "United Methodist Women" dropping the name, "Women's Division." United Methodist Women is already incorporated as a not for profit organization, as all boards of The United Methodist Church are. So it would be a change in name. It would not be a board or a commission in the disciplinary sense, but an agency of The United Methodist Church.

These changes come out of the proposal recognizing, "some (more) of our institutional language must disappear, and we must have less focus on the UMW organization and more focus on our amazing praying, serving and advocating members."

Implementation of Plan

Because some of United Methodist Women's structures are described in the Book of Discipline, some legislation will have to be brought forward to General Conference for a vote in 2012, and will not be implemented officially until January 2013. However, United Methodist Women will prepare for implementation following General Conference.

This plan "will strengthen United Methodist Women's identification with our work in the world and will enhance our strong witness in the church and the world," said Ms. Olson. "We need to continue to find clearer ways to show and tell what we are accomplishing as an organization. The members deserve to know that they make a difference."

Proposed Standing Rules Changes

VIII FUNDS Art. VII , page 108

A. A percentage of the conference undesignated receipts **mission giving** shall be used for the administration and membership development expenses of the conference, a contribution to the jurisdiction fund for administration and membership development, and a remittance to the districts for administration and membership development; \$300.00 from each district's administration and membership development funds shall be designated for representation by districts beyond the conference to Assembly and/or Jurisdiction.

B. Each districts shall return any unused funds to the Conference Treasurer at the end of each year.

By December 15, annually, districts shall return to the conference treasurer any monies left in their treasury, with the exception of an annual start up fund of up to \$500. The other exception is noted in F. below.

C. Any remittances from the districts that do not meet the deadline will be credited in the next year.

D. The conference treasurer shall establish an Administration & Membership Development Pool from which districts may draw, by request, to fulfill the needs and opportunities of their district budgeting.

E. In the first quarter of the year, district treasurers shall subtract the \$500 start up monies from their request for funds from the A&MD Pool.

C.F. The only **other** monies a district may hold at year's end are:

1. \$50.00 for workshops. This money may accrue;
2. \$25.00 per year that may be put into savings for up to five years for Scholarships to Church Women United.

D.G. Each member of the local unit may give \$2.00 per year to supplement the Administration and Membership Development expenses.

E.H. The conference organization may support Blue Lake Project. Funds for Blue Lake may be secured through the asking of \$2.00 per year.

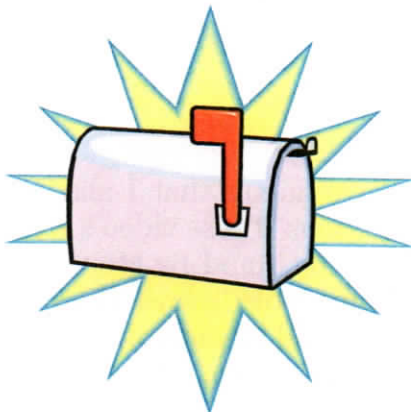
